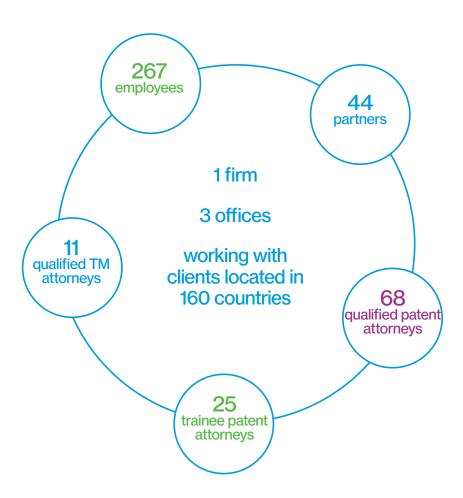

What is intellectual property?

Intellectual property (IP) is a legal concept referring to "creations of the mind" such as musical, literary, and artistic works, inventions, words, phrases, symbols, and designs. IP law grants owners certain exclusive rights to these intangible assets.

There are several types of intellectual property rights:

- Patents protect technical inventions.
- Trade marks protect the brand and brand name and can include colours, symbols and logos.
- Copyright protects literary, musical, dramatic and artistic works.
- Designs protect the visual appearance of products.

What is a patent?

A patent is an agreement between the patent holder and the state that can prevent others from exploiting an invention for up to 20 years (subject to annual renewal).

It is both a technical and legal document that must accurately convey to an expert in the relevant technical field how the invention works.

In exchange for telling the world how the invention works, a patent gives the inventor a time-limited legal monopoly over the invention.

To gain a patent the idea must not previously have been publicly disclosed, used or sold before a patent application has been filed as this will almost certainly invalidate any patent eventually granted.

An invention will also need to be new, inventive (not obvious) and have practical (industrial) application.

A patent attorney's role is to assist clients in protecting their inventions by both preparing new patent applications and defending patent applications before the world's patent offices.

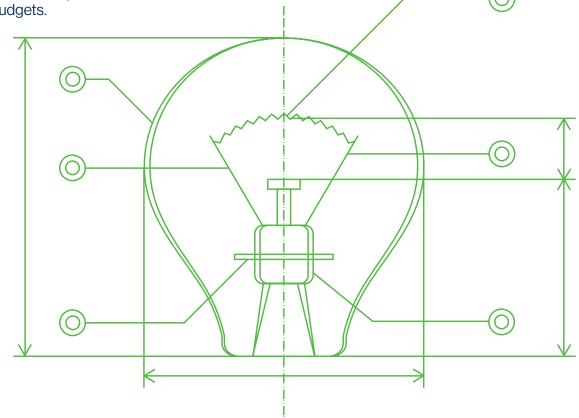
IP is worth billions to the world economy and as such is of significant commercial value to a company. Robust protection of IP rights, whether through the use of patents, designs or trade marks, is vital to the success of a company. The role of a patent attorney is to help companies achieve key strategic goals by helping them obtain and maintain protection of their innovations.

A patent attorney works with clients and inventors to balance the law and complex methodological and/or scientific issues. At the same time, a patent attorney must be able to understand and address the strategic aims of a company and what it wants to achieve through the protection of its intellectual property. In addition to achieving all of this, a patent attorney must also work within the client's commercial constraints, such as timelines and budgets.

We work with clients to write specifications, which detail the invention and a description of the practical form(s) of the invention, usually with the aid of drawings. A patent attorney needs to be able to describe accurately the elements of the invention. In order to do this a deep understanding of the technology behind the patent is needed.

We often work directly with the inventor(s) to work out which elements of the invention might be patentable. However, we also need to be able to work with those in a business charged with creating commercial value from the invention.

A patent attorney may also work on oppositions – either defending or opposing the validity of a patent on behalf of our clients. The ability to form and articulate coherent arguments based on law is therefore imperative. A patent attorney will need to be comfortable handling contentious situations and have the ability to think quickly under pressure.

Top-quality training

As a trainee patent attorney at D Young & Co you will receive training and take exams to become both a UK Chartered Patent Attorney and a European Patent Attorney.

There are a number of qualifications needed to become a patent attorney and the process can take approximately four to six years in total. Although the exams are notoriously difficult and the training can be challenging, the result will be worth it. The training you receive from us will be second to none and you will be given responsibility and introduced to clients early on in your career.

To help you pass the exams, we offer additional support outside of your on-the-job training. As well as attending formal external courses you will enjoy one to one mentoring by a dedicated partner whilst being able to receive a broad church of work from a variety of our qualified attorneys, as well as having access to study resources, internal tutorials and external revision courses to support you through exams. This is alongside your own preparation and revision for the examinations.

We look to recruit six to seven technical assistants each year so you will progress through the qualifications with the support of other trainees around you, those at your level and those in the years above. Study leave is provided for courses, exams and revision time. Travel, accommodation and expenses are also paid for.

Tailored and adaptive training

POINT OF QUALIFICATION

ESSENTIAL SKILLS FOR A TRAINEE

Essential skills for a trainee patent attorney

As a trainee you will rely on a number of core skills to successfully navigate your training and progress in your career as a patent attorney, these include:

- Excellent written and verbal communication skills that enable you to summarise and communicate complex legal situations to non-experts.
- Reading and quickly assimilating relevant information from several, often lengthy and detailed, technical and legal documents.
- Strong analytical skills, identifying the key differences between the technologies described in a set of documents.
- Meticulous attention to detail.
- Preparing accurate and appropriate amendments to a patent application specification to enable the patent to be differentiated from other cited references.
- Preparing succinct, accurate and persuasive arguments for why the patent application specification is different from the cited references in a legally and technically sound manner.
- Working well in a team as well as autonomously.
- Working under time pressure to tight deadlines using impeccable time management skills.

A TYPICAL DAY AS A TRAINEE

Meetings with your supervisor to discuss work Talking through the legal and technical feedback provided in order to make amendments to the work before it can be signed off.

Studying relevant technologies and legal documentation including legal texts, case law and guides on the law.

Reading documents associated with cases
For example a patent application, patent office
examination report and reference documents.
You need to understand the patent application,
see how it differs from the reference documents
and decide what options are available to respond
to the objections in the examination report.

Working on the preparation of new patent applications

This typically involves reviewing a written disclosure provided by the inventor and then meeting with the inventor in order to gain a full understanding of their invention. You will aim to have a technical understanding as well as an appreciation of what the client's commercial goals are. Your job is to pick out the critical points in terms of patent protection and quickly understand what matters more and what matters less.

Working with colleagues across our offices or remotely We provide video conference facilities for excellent inter-office collaboration and all of our files are held electronically to permit working on any matter in any office or indeed remotely.

Working on patent applications which have already been prepared and filed

The patent office will issue an examination report which will set out objections – these objections may be raised on the basis of a comparison which the patent examiner has made to technologies already known and / or to the manner in which the claimed invention is described. Your job is to respond to these objections by either making amendments, or by arguing that the examiner is legally or technically incorrect.

When you have passed all of your examinations and become a qualified patent attorney, you will begin to manage your own cases and clients.
